U.S. TAG for JOINT ISO/CIE STANDARDS COMMITTEE REPORT

November 11, 2010

The U.S. TAG for Joint ISO/CIE Standards Committee has completed a number of tasks since the CIE/USA Annual Meeting in October 2009. A summary of the committees' activities is as follows:

- 1. The TAG held its third annual meeting on October 15, 2009 in Gaithersburg, Maryland at the National Institute of Standards and Technology (NIST). The meeting was conducted on-site and via audio teleconference and was attended by 9 members of the TAG and 2 guests.**
- 2. On December 10, 2009 the TAG distributed ISO 28077 "Photocarcinogenesis Action Spectrum (non-melanoma skin cancers) and ISO 8995-3 "Lighting of Work Places – Part 3: Lighting Requirements for Safety and Security of Outdoor Work Places" for systematic review. Completed review forms, for both documents, were due no later than Friday, February 19, 2010.**
- 3. On January 28, 2010 the TAG Administrator completed and sent to the ANSI ISOT the "2009 Annual Report for the U.S. TAG for Joint ISO/CIE Standards", List of TAG members and a list of TAG interest categories.**
- 4. On March 8, 2010 the TAG Administrator sent the completed U.S. Ballot forms for ISO 20877 and ISO 8995-3 to the ANSI ISOT. The TAG vote was to "affirm" both standards with no comments. On March 10, 2010 the ANSI ISOT confirmed receipt of the TAG ballots.**
- 5. On May 18, 2010 the TAG Administrator sent a completed "ANSI-Accredited U.S. TAG to ISO Procedural Compliance Survey" to the ANSI ISOT.**
- 6. On October 26, 2010 The TAG Administrator notified all members of the TAG that the TAG Annual Meeting would take place on Tuesday, December 14, 2010. The meeting will be conducted via audio teleconference and the meeting agenda will be distributed 30 days prior to the meeting date.**

- 7. On November 5, 2010 the TAG distributed ISO 30061:2007 “Emergency Lighting” for systematic review. Completed TAG review forms are due no later than February 18, 2011.**

- 8. On November 6, 2010 the TAG distributed ISO 11664-1:2007 “Colorimetry – Part 1: CIE Standard Colorimetric Observers” and ISO 11664-2:2007 “Colorimetry – Part 2: CIE Standard Illuminants” for systematic review. Completed TAG review forms are due, for both documents, no later than Friday, February 18, 2011.**

- 9. On November 11, 2010 the TAG Chairman presented this report at the CIE/USA Executive Committee and Technical Council meetings in Toronto, Canada.**
