## **U.S. TAG for JOINT ISO/CIE STANDARDS COMMITTEE REPORT**

**October 4, 2011**

**Document #2011N11**

**The U.S. TAG for Joint ISO/CIE Standards Committee has completed a number of tasks since the CIE/USA Annual Meeting in November 2010. A summary of the committees' activities is as follows:**

- 1. On November 15, 2010 a U.S. TAG Membership Ballot was distributed for Hyman Kaplan. The due date for all returned ballots was December 17, 2010.**
- 2. The TAG held its annual meeting on Tuesday, December 14, 2010. The meeting was conducted via audio teleconference and was attended by 8 members of the TAG and 1 guest.**
- 3. On December 13, 2010 a U.S. TAG Membership Ballot was distributed for Ann McCarthy. The due date for all returned ballots was January 14, 2010.**
- 4. On January 20, 2011 the TAG Administrator notified Hyman Kaplan and Ann McCarthy that based on the returned TAG Membership Ballots both were elected as general members of the TAG.**
- 5. On January 28, 2011 The TAG Administrator completed and sent to the ANSI ISOT the "2010 Annual Report for the U.S. TAG for Joint ISO/CIE Standards", List of TAG members and a list of TAG interest categories.**

**On January 28, 2011 the TAG Administrator distributed the following ISO/CIE Standards for systematic review:**

- ISO 30061:2007(E) "Emergency Lighting"**
  - ISO 11664-1:2007 "Colorimetry – Part 1: CIE Standard Colorimetric Observers"**
  - ISO 11664-2:2007 "Colorimetry – Part 2: CIE Standard Illuminants"**
- 6. On March 7, 2011 the TAG Administrator sent the completed U.S Systematic Review Ballot forms, to ANSI ISOT, for ISO 30061, 11664-1 and 11664-2. The TAG review recommendation was to "APPROVE" all three standards with no comments.**

- 7. On March 23, 2011 the TAG Administrator sent to ANSI ISOT the annual U.S. TAG Compliance Survey”.**
- 8. On September 23, 2011 at the CIE/USA Executive Committee teleconference meeting the TAG Chairman announced that the TAG annual meeting would be conducted via teleconference in December 2011. The meeting agenda will be distributed 30 days prior to the meeting date.**
- 9. On October 1, 2011 the TAG Administrator sent an email to all current TAG members announcing a call for members who wish to run for the position of TAG chairman or vice-chairman. The deadline for response is October 31, 2011 and the actual TAG Officer Ballot will be sent on or about November 7, 2011.**

**On October 1, 2011 The TAG Task Force began the process of reviewing the current TAG Operating Procedures. The Task Force plans to have the TAG Operating Procedures ready for balloting by mid-January 2012.**

- 10. On October 4, 2011 the TAG Chairman presented this report at the CIE/USA Executive Committee and Technical Council meetings in Ottawa, Canada.**
